Thank you for your interest in becoming a member of the Clark County Junior Fair Board. The Junior Fair Board is a great way to meet new people and get more involved in the Clark County Fair and community

Junior Fair Board members must be no less than a Freshman in high school and no more than a freshman in college; and may not have reached their 20th birthday by January 1st of the current year. Members must also have participated in the Clark County Fair within two years prior to their application to the Junior Fair Board. Members are elected to a two-year term and have the opportunity to reapply for an additional year if their age allows them to do so.

Junior Fair Board members are required to attend one regular meeting each month. Other responsibilities include serving on various committees for community service and Fair events, organizing and implementing Junior Fair Board sponsored events at the Fair and throughout the non-Fair season, and assisting the Senior Fair Board with various activities throughout the year. During the week of the Fair, the Junior Fair Board members assist with livestock shows and sales; work at the track events, and many other important activities.

If you feel you are interested in joining the Junior Fair Board, please fill out the attached application. Applications are due to the Senior Fair Board office by September 3, 2019. Interviews will be held on Sunday, September 8, 2019 at the Clark County Extension Office. Members selected to serve on the board will be notified by mail and should plan to attend their first Junior Fair Board meeting on Sunday, October 13, 2018 at 1:30 p.m. at the extension office. Please try to keep these dates open.
