## **Buyer Terms & Conditions:**

- **1. Buyer Registration:** New buyers may register beginning April 1 at <a href="https://www.ccjrfairsales.com/buyers">www.ccjrfairsales.com/buyers</a>. Returning buyers do not need to register.
- **2. Auctions:** Buyers may participate in one or more of the 2024 4-H & FFA premium sales. Buyers are providing a financial premium for the exhibitor's experience and will not receive the exhibitor's project or product except for items sold in the Art & Bakers Auction.
  - a. Art & Baker's Auction
  - b. Sale of Champions & Jr. Fair Market Project Live Auction
  - c. Online Premium Sale
- **3.** Add-Ons: Buyers may add-on to any exhibitor participating in one of the three sales. Add-On sheets are available online at <a href="www.ccjrfairsales.com">www.ccjrfairsales.com</a> and at the sales office during the fair. Add-On sheets may be submitted via email <a href="mailto:jrfairsales@gmail.com">jrfairsales@gmail.com</a> until Friday, August 3.
- **4.** Live Auctions: Auctioneers and ring persons will take bids.
  - a. The highest bidder(s) will be responsible for paying the final bid for each auction entry.
  - b. The live auction will begin with the Sale of Champions with remaining entries selling randomly. A sale order will be posted to <a href="https://www.ccjrfairsales.com">www.ccjrfairsales.com</a> and at the auction.

- **5. Online Premium Sale:** The Online Premium Sale will open from July 30 Aug. 3, 2023 at <a href="www.ccjrfairsales.com">www.ccjrfairsales.com</a>. The Online Premium Sale provides all buyers the opportunity to place monetary add-ons to a 4-H or FFA Member's Jr. Fair Experience
- 6. Terms:
  - a. Invoices for all sale formats will be sent out after the close of the online sale and will be due within 30 days of the invoice date.
  - b. We accept Cash, Checks, Visa, Mastercard, Discover & American Express. A 3% buyer premium will be waived for those paying with cash or check. Please make Checks payable to Clark County Jr. Livestock Auction.
  - c. Buyers with outstanding invoices will not be eligible to participate in any of the sales until the outstanding balances are paid.
- 7. Participate at Your Own Risk: All persons attending the Auction do so at their own risk. The owners or anyone connected with the management of the sales assume no liability, legal or otherwise, for any accidents that occur.
- 8. Purchasers of Champions:
  - a. Ohio Department of Agriculture requires that the Champion and Reserve Champion market beef, dairy steer, lamb, hog and goat go to harvest. Overall and Scramble Champions and Overall Reserve Champions (market beef, dairy steer, lamb, hog and goat) will be sent to local custom processors arranged by the Sales Management Team. Buyers are not eligible to receive meat from the champions.
  - b. Champion and Reserve Champion dairy feeder must be sent to United Producers and are not eligible to be shown by that exhibitor or any other 4-H/FFA member in any junior show including buy not limited to any Ohio County, Independent or State Fair.
  - c. Champion rabbits, ducks, chickens, and turkeys may not be given back to the exhibitor. These animals also must be loaded onto the packer truck.
- **9. Photographs of Champions:** Photographs of champions will be taken in the auction ring and used in buyer recognition and auction promotion. These photographs will available upon request to the Sales Office
- **10.** Buyer Benefits: If your account is settled by October 1, 2024, you will receive:
  - a. Name listed on the Clark County Jr. Livestock Auction website.
  - b. Name listed on the Maine's Building located on the Fairgrounds.
  - c. If you spend \$150 or more, you will receive a buyer placard, \$5.00 coupon redeemable at any FFA Food Trailer, 4-H Ice Cream Booth or Pork Producers.

**Purchaser's Obligation:** The above terms of sale shall constitute a contract between the buyers and sellers and shall be equally binding upon both.

## **Exhibitor Terms and Conditions:**

#### 1. Sale Eligibility:

- a. 4-H and FFA exhibitors must have met membership and entry requirements, completed a 4-H or FFA Market project, and met show requirements to be eligible for champions within their project(s) making them eligible to enter their 4-H and FFA experience.
- b. The Art & Bakers auction is a separate auction from the Junior Fair Livestock Auction. Only champions from the classes sell in the Art & Bakers Auction.
- c. 4-H and FFA Exhibitors must care for all their projects until animals are released to go home or on the packer truck as designated on their respective declaration. Exhibitors in violation will forfeit all selling rights including but not limited to online or live auction premiums.

## 2. Auction Registration:

- a. 4-H and FFA exhibitors must register for the Clark County Jr. Fair Auctions by July
  1 on Fair Entry <a href="https://clarkohjrfair.fairentry.com">https://clarkohjrfair.fairentry.com</a>. At entry, exhibitor must
  determine live auction or online experience sale.
- b. A 4-H and FFA exhibitor photo shoot will be held on June 11, 12 and July 9 from 5 p.m. 9 p.m. in the Mercantile Building. Every exhibitor that plans to participate in the Jr. Fair Experience Online Sale must have a photo taken by the Sales Committee on these dates. Each exhibitor must come in SHOWMANSHIP ATTIRE!

#### 3. Declarations:

- a. 4-H and FFA exhibitors MUST complete an online declaration within 30 minutes after weigh-in stating whether their project is going home or on the packer truck. The online links and QR codes for declarations will be posted on the 4-H app, Fair, Sales and 4-H websites and at all Fair check-ins.
- b. Species Rules determine load out requirements for all projects.
- c. Declaration changes may be made up until noon of the day of load out to go home or on the packer truck with the last day being Thursday, July 25 at noon. These changes need to be made in person at the Sales Office.
- d. Exhibitors will only receive packer resell for those animals declared to go on the packer truck on the project declarations.
- **4. Auction Withdrawal:** Exhibitors may withdraw from the Live or Online Sales up until noon on Thursday, July 25 at the Sales Office. This must be done in person.

#### 5. Exhibitors of Champions:

- All Grand/Overall Champions, Reserve Grand/Overall Champions including Scramble Champions must be sold through the Champions Showcase – no exceptions!
- Overall Premier Exhibitors may choose to sell in the Champion Showcase, but are not required to do so unless the exhibitor also has one of the Overall Champions/Reserve Champions or Scramble Champions
- **6. Sale Weight:** All animals will be weighed by an official weigh master on certified scales at the respective animal weigh-ins on the first Friday of the Fair. This recorded weight will serve as the official sale weight for resale value.

## 7. Harvest Requirements:

- a. Sr. Fair Board Species Committee is responsible for the chain of identification from the time of naming a champion to the time of sale.
- b. Per ODA rules, Overall Grand and Overall Reserve Champion (market beef, dairy market steer, market hog, market lamb and market goat) will be harvested as soon as possible after the Auction by Copey's Butcher Shop. Clark County Fair requires all scramble champions to be harvested at Copey's Butcher Shop as well.
- c. All champions must be harvested or loaded on the packer truck. Champion and Reserve Champion Dairy Feeder must go on the packer Truck.

### 8. Sale Deductions:

- a. Each exhibitor/seller's check will have a 5% sales commission deducted from their live or online proceeds and a \$5.00 handling fee.
- b. Check-off dollars will be deducted according to the National Commodity Check-off Program requirements.

## 9. Exhibitor/Seller Payment:

- a. Exhibitor/sellers will not be issued their sale check until their entire account has been paid in full or not later than 90 days after buyers have been invoiced.
- b. Resale checks will be issued 2-4 weeks after the close of the Fair for all animals that are loaded on the packer trucks.
- c. All exhibitor checks are stamped VOID AFTER 90 DAYS.
- d. If the Sales Manager must reprint a seller's check within 90 days of issuance, there will be a \$35.00 reissue fee.
- e. All checks not cashed after 90 days will become a donation to the Clark County Jr. Fair Livestock Auction.
- **10. Rule Observance:** Failure by any exhibitor to adhere to any sale rules could exclude the exhibitor from selling and future sale participation.
- **11. Custom Processing:** We are no longer offering custom processing. Buyers need to make all arrangements for custom processing prior to the fair.
